The Practical Nursing program has a selective admissions process. The cap on annual student enrollment is 30 for each Fall admission. This packet will outline minimum criteria, program coursework, and the application/selection process. Before applying, it is recommended to review the [Technical Standards and Essential Functions](#) required for the program. Reading these standards carefully along with a realistic assessment of your own personality, interests, abilities, strengths, and weaknesses will ensure that you choose a program and career path that is a good fit for you. *Please read the contents of this packet carefully and in its entirety as some requirements are time-sensitive.*

### PROGRAM APPLICATION REQUIREMENTS

- ✓ **Complete the GTCC General Admission/Readmission Process (new and returning students).**
  - *Students currently enrolled at GTCC do not need to complete a new application for admission. These students will begin with the remaining steps and make sure the NC Residency is current.*

  - *It is **highly recommended** to have this step completed by March 17<sup>th</sup>.*
- ✓ **Complete the REQUIRED online Program Information Session by March 24<sup>th</sup>.**
  - *See page 2 for instructions for accessing the session.*
  - *Sessions completed for previous admission cycles are **NOT** acceptable.*
- ✓ **Demonstrate “college readiness” for English and Mathematics.**
  - *See page 3 to view options for meeting this requirement.*
- ✓ **Demonstrate BIOLOGY competency**
  - *See page 3 to view options for meeting this requirement.*
- ✓ **Hold current certification as a Nurse Aide I on the NC Nurse Aide Registry with no substantiated findings.**
  - *See page 3 for information on this requirement.*
- ✓ **Complete the ATI TEAS and achieve a minimum composite score of 66.**
  - *ATI TEAS scores must be **no older than two years** from the Limited Entry Program start date (2021).*
  - *Prior versions of the TEAS (i.e. TEAS IV, TEAS V) will not be accepted.*

- ✓ **Submit the Fall 2023 Practical Nursing Program Application**
  - *Applications can be submitted **February 27<sup>th</sup> – March 31<sup>st</sup>**.*

**Note:** Meeting all criteria listed above does not guarantee acceptance to the program. However, all criteria must be met to apply and be considered for selection.

## LIMITED ENTRY ADMISSION PROCESS – GTCC HEALTH SCIENCES PROGRAMS MEET PROGRAM ADMISSION REQUIREMENTS

### Complete the GTCC General Admission Process (New and Returning Students)

- **New and returning GTCC students must complete the GTCC general admission, including the North Carolina Residency Determination Service (RDS).** To get started, visit <https://www.gtcc.edu/admissions-and-aid/apply-now.php>
  - **Returning students=** students previously admitted to GTCC and have been not enrolled in courses at for more than 12 months
- **Submit your official transcripts to the GTCC Admissions Office.** Once received, transcripts are evaluated by GTCC’s Enrollment Services staff. Approved transfer credits will be added to your academic record as appropriate.
  - **Please allow a minimum of TWO WEEKS for evaluation to occur.** This process takes longer near the beginning or end of a semester. Transfer credits from regionally-accredited colleges/universities **must** appear on your GTCC WebAdvisor transcript in order to be considered for meeting program requirements and/or earning ranking points.
- **Activate your GTCC Titan Account.** You should be able to do this within 48 hours of completing your GTCC Application.

### Complete the Required Online Program Information Session by 5pm, March 24<sup>th</sup>

**Information Sessions completed for previous application cycles are not acceptable for purposes of meeting this requirement!**

This session will provide you with a detailed overview of the program, faculty and student expectations, class schedules and clinical requirements, the minimum program admission requirements, submitting your program application, and the selection and notification process for the incoming class.

- **You must have an activated Titan account to access the information session.**
- Enroll yourself in [Limited Entry Health Programs Information Sessions Canvas course](#) and complete the **Fall 2023 Practical Nursing module**. You must pass all three modules with a score of 100% to receive credit for this task and access the program application. **Access to the session will close at 5pm on March 24<sup>th</sup>!**

## Demonstrate College Readiness for English AND Mathematics

You must be able to demonstrate that you have achieved the appropriate levels of college readiness in both subject areas. The chart below shows options for meeting these requirements.

## Demonstrate Biology Competency

Applicants can meet this requirement one of the following ways:

- College-level BIO/lab course with a "C" or better, completed within 10 years of program start date— (since 2013)
  - The course must be reflected on your transcript in WebAdvisor.
- High school-level BIO/lab course with a "C" or better, completed since the 2019-2020 school year
  - Your high school transcript must be on file in Admissions.

## Hold Current Certification as a North Carolina Nurse Aide I with No Substantiated Findings

Applicants are required to have a current NA I Registry listing (CNA certification) prior to submitting the program application. You must keep this certification current throughout the Nursing Program.

- If you have not completed the certification, you can request to be added to the contact list for upcoming GTCC trainings by emailing Amy Byerly ([aeleonard@gtcc.edu](mailto:aeleonard@gtcc.edu)). For a list of all state-approved trainings, you can visit [NC Nurse Aide Registry site](#).
- You must upload a copy of your Registry Listing with the Program application. Visit the NC Nurse Aide Registry Verification Page ([https://ncnar.ncdhs.gov/verify\\_listings1.jsp](https://ncnar.ncdhs.gov/verify_listings1.jsp)) to access your listing.

## Complete the ATI TEAS and Achieve a Minimum Composite Score of 66

You may schedule your ATI TEAS through the GTCC Assessment Center or an ATI-approved testing center. **Your ATI TEAS scores may be no older than two years from the Limited Entry Program Start date (2021).**

## **NEW** SUBMITTING YOUR PROGRAM APPLICATION

**Program Applications will be accepted February 27<sup>th</sup> through 5pm on March 31<sup>st</sup>, 2023.**

Once have completed all of the minimum admission requirements, it's time to submit your program application. This will be completed electronically through the *Limited Entry Health Programs Information Sessions* course in Canvas. Once you have completed all three modules with a score of 100% the link for the application can be accessed starting February 27, 2023.

- Only one submission will be permitted for each applicant
- You will be required to upload your NA I Registry Listing
- You will be required to upload a copy of your ATI TEAS score
- If applicable, you will upload documentation of other ranking criteria
- **It is critical that you check your WebAdvisor transcript to make sure all coursework is accounted for, including transfer credits. Ranking points will only be given for courses that are on record. It is your responsibility to ensure all official transcripts have been submitted to Admissions and processed for transfer credits.**
- Incomplete and/or ineligible applications will not be moved forward
- **Applications will not be reviewed by the Limited Entry Programs Office until after the March 31<sup>st</sup> deadline. It is important to make sure all requirements are met BEFORE submitting your application.**

## PROGRAM APPLICANT SELECTION AND NOTIFICATION PROCESS

### Ranking and Selection Process

One to two weeks following the March 31<sup>st</sup> deadline, all application submissions will be screened by the Limited Entry Programs Office to confirm all minimum criteria has been met. All applicants will be notified via GTCC email if their submission will be moved forward to the Selection Committee for the final ranking review.

The next 2-3 weeks following the initial screening, the Health Sciences Review Committee (comprised of Health Sciences Program Directors and faculty, Dean of Health Sciences, and Limited Entry Programs Office Staff) will review all eligible applications.

**Applicants are ranked using a points system and will be selected based on the total points earned (see the next page).** Ties will be decided based on the following criteria: 1) The total points earned in the "General Education Courses" ranking section; 2) The ATI TEAS composite score; and 3) The date of the Limited Entry Program Application for the program of interest.

### Notification Process

Final results will be sent electronically to the applicant's GTCC email address **approximately** 4 weeks after the application deadline. It is the applicant's responsibility to check this email account frequently to avoid missing important communications from GTCC!

- **Applicants offered a seat must accept or decline a program position by submitting an Intent to Enroll Form within 5 calendar days of the date on the acceptance letter.** Failure to respond within the stated timeframe will result in the position being offered to an alternate. Once a student declines a program position, the decision may not be reversed.
- **Applicants have 7 business days from the date on the notification letter to contest the results of the selection process.** The request for review of the results must be submitted in writing to Ms. Monica Banks, Limited Entry Program Coordinator (mvbanks@gtcc.edu). Ms. Banks will route your appeal to the authorized administrator who will render a decision within 7-10 business days of receipt of the written request. **The Administrator's decision is final.**

**Official AP scores must have been submitted to the GTCC Admissions Office to earn AP course credit.** Advanced Placement credits for BIO and CHM courses must have been awarded within ten years of the program’s start date (since 2013).

## PROGRAM ORIENTATION, ADVISING/REGISTRATION, AND ENROLLMENT

Once a position in a program of study is accepted, the student will then communicate with the Program Director regarding all matters related to program orientation, advising/registration, and enrollment.

The student is required to attend all program orientations, meetings, or other events scheduled prior to the start of classes. Failure to attend these meetings without prior approval from the Program Director will result in removal from the health program; an alternate student will be selected to fill the vacant position, as directed by the Program Director.

The student must enroll in program classes prior to the first day of the semester. Failure to enroll without prior approval of the Program Director will result in removal from the health program.

A student who enrolls in first-semester classes for the program and withdraws from the program or is dropped from the program that semester must complete the entire program admission process if he/she wishes to apply for a future program entry.

*The GTCC Health Sciences Limited Entry Process is not to be regarded as a contract between GTCC and students. GTCC reserves the right to change any provisions or requirements with adequate notice and minimum disruption to students.*

### Important Notes to Health Science Program Applicants

Program faculty reserve the right to revise or change course requirements in accordance with applicable state laws, college requirements, accreditation standards, and/or at the discretion of the faculty. By accepting admission into the program, students agree to at all times abide by the program requirements and procedures as set forth in the Student Handbook and the respective course syllabus issued at the beginning of each term for each course. The student is bound by such requirements and procedures regardless of whether they were established before or after the date of enrollment in the program. Changes made after the publication of the Handbook will be posted as an addendum to the Handbook.

Most programs require students to have a criminal background check, a drug screen, and an OIG review (Office of Inspector General) upon admission. Healthcare agencies that are utilized for clinical and/or internship experiences require this evaluation. If a student is denied agency access due to a positive check or screening, the student may not be able to complete the clinical education experiences, which will result in the inability to continue in the health science program. Screening may also be required after graduation by examination boards, state licensing boards, and employing agencies. Pending the outcome, a graduate may be disqualified from examination eligibility, state licensure, and/or employment.

Students must achieve a GPA of 2.0 or better in order to graduate. Students who receive a grade of "D" in a general education course (other than BIO or CHM) can graduate as long as their GPA is at least 2.0. However, a grade of "D" in a general education course will not transfer to another institution, nor will GTCC accept a grade of "D" for credit from another institution. Students must achieve a "C" or better in BIO, CHM, and program major courses. Students who do not achieve a "C" or better in these courses will be suspended from the program.
